Lane Closure and Work Zone Updates for Orlando Extension  
(Phase 2 - South Florida to Orlando)**

**ORLANDO, FL.** (November 2, 2021) – Brightline announces lane closures, work zone, railroad crossing and bridge work information for Phase 2 construction from Orlando to West Palm Beach, connecting Orlando to South Florida.
