



BRIGHTLINE CONSTRUCTION ADVISORY: LANE CLOSURE AND WORK ZONE UPDATES FOR ORLANDO EXTENSION (SOUTH FLORIDA TO ORLANDO)

ORLANDO (January 3, 2022) – Brightline announces lane closures, work zone, railroad crossing and bridge work information for Phase 2 construction from Orlando to West Palm Beach, connecting Orlando to South Florida.
