Describe outcomes of Four-Factor Analysis for Limited English Proficiency

Martin County utilized American Community Survey data within the 2019 5-Year Language Spoken at Home for the Population 5 Years and Over table (C16001). Based on this data, no language group exceeds 5% of Martin County's population.

2. The frequency with which the LEP persons come into contact with the program.

The proposed project will provide job training and other learning opportunities for LEP persons, among many Martin County residents, on an ongoing basis.

3. The nature and importance of the program, activity, or service provided by the program.

The pandemic has highlighted a desperate need to reeducate or up-skill the existing and entering workforce in Martin County. Martin County seeks to rehabilitate Building 17 at Witham Field to operate as a Learning Center, with job training and other educational opportunities available from Indian River State College. Low- and moderate-income (LMI) individuals are the target audience for this training, including LEP persons.

4. The resources available and costs to the recipient.

Martin County provides translation services of all public notices. Additionally, Martin County uses the Language Line Solutions service to provide translation services to communicate with LEP residents. Martin County is also proposing to conduct English as a Second Language courses at the training center. Therefore, these limited LAP measures are reasonable given the resources available to Martin County.

Describe the methods used to solicit participation of low- and moderate-income persons in public hearing(s):

Martin County published a public notice in the TC Palm newspaper on March 9 seeking comment from residents on the proposed construction of a workforce training center. That announcement solicited comments from businesses seeking to train workers and low-/moderate-income residents who have lost jobs as a result of the pandemic. The goal of the public hearing was to determine interest, identify workforce skill needs in certain fields (e.g., health care, aviation), and begin to align interests with workforce training center programming.

Information was also posted to the Martin County web site announcing the public hearing and providing access to the CDBG-CV application.

Project/Program Title:

Development of Countywide Learning Center at Witham Field

Project/Program Description: Describe the proposed project/program. Limit to 500 words.

The proposed project involves the rehabilitation of Building 17 at the Martin County airport – Witham Field – as a Learning Center to support LMI residents that have lost employment resulting from COVID-19. The health crisis has significantly impacted Martin County's economy, particularly the retail, dining, hospitality, and service industry sectors. Martin County is partnering with Indian River State College to deliver vocational training that will prepare workers for post-pandemic careers. This training will focus on the health care, marine, and aviation/aerospace sectors. The Learning Center will also provide LMI residents with classroom opportunities to enhance English language skills, improve financial literacy, and practice interviewing techniques.

According to the Florida Department of Health, as of March 1, 2021, Martin County has seen 10,415 total cases of COVID-19, with 691 hospitalizations and 284 deaths. More than 15,000 workers across Martin County (including 3,750 in the retail, hotel, and food service sectors) have filed for unemployment benefits from the start of the outbreak through January 30, 2021. COVID-19 continues to affect the area's health and economy; Florida's first case of the B.1.1.7 coronavirus variant was discovered in Martin County.

Since the onset of the pandemic, many local businesses, especially retail shops, personal service industries, and restaurateurs, have been affected by the loss of customers. In most cases, these businesses have had to make cuts to maintain a bottom line, adapt to new businesses procedures, reduce worker hours, and in some cases close entirely. This has led to rising unemployment and underemployment in Martin County.

Martin County has coordinated with Indian River State College and regional employers to develop the proposed Learning Center concept. Through collaborative sessions with the Business Development Board of Martin County, the Martin County Economic Council, the Stuart/Martin County Chamber of Commerce, and other business non-profits, Martin County has identified training opportunities that will help to diversify the regional economy. Health care is emerging sector with locally-based Martin Health System and the expansion of the Cleveland Clinic hospital

campus in adjacent St. Lucie County, presenting openings for entry-level jobs including medical assistants, lab techs, and other health aides. Home to a \$227 million maritime economy that supports more than 5,000 jobs, Martin County FL is an ideal location for marine-based companies. Long a hub for aviation/aerospace products and services, Martin County is also ideally suited to meet the needs of growing companies in this sector.

CDBG-CV investment will help Martin County develop a Learning Center to respond to the economic impacts of the pandemic. Following construction, affirmative marketing and outreach will be conducted to attract unemployed and underemployed residents to workforce training opportunities at the facility. Income certification will be conducted to ensure that at least 51% of Learning Center users meet HUD LMI requirements. Private sector companies are already committing to interview and apprentice trained workers.

Specifically, CDBG-CV grant funds will support:

- design and engineering of the Learning Center;
- Building 17 renovations;
- creation of vocational classrooms; and
- sitework and landscaping.

The current pandemic has crippled Martin County. The region has experienced job loss, rising unemployment, and other economic hardship as a result of the health crisis. Before the pandemic, the unemployment rate in Martin County was 3.0%. By April 2020, unemployment had risen to 11.8% as social distancing measures shut down workplaces, causing job losses across nearly every sector. While unemployment has slowly declined, many Martin County residents remain unemployed or underemployed.

Traditionally, tourism has been a key economic driver in Martin County. However, many of the businesses in Martin County most affected by COVID-19 are within the retail, dining, hospitality, and service industry sectors. Studies show that nearly 40% of these small businesses never reopen after a major disaster. As some of these jobs will never return, Martin County seeks to expand employment opportunities for LMI residents in the emerging health care, marine, and aviation/aerospace sectors. A diversified economy will create new career paths in the region.

CDBG-CV investment aligns with Martin County's long-term economic development goals. A principal goal of Martin County is to promote balanced, sustainable growth. The proposed Learning Center directly support Policy 15.2B.5 of the Comprehensive Growth Management Plan – "Martin County shall encourage and pursue opportunities for life science and aerospace industries and related businesses."

Based in Stuart, Martin Health System comprises three hospitals, one MediCenter, a free-standing emergency center, and numerous centers and clinics. In nearby St. Lucie County, Cleveland Clinic Tradition Hospital is expanding operations with plans to conduct biomedical research in Port St.

Lucie, its first research facility outside of Cleveland. This work at the Florida Research and Innovations Center will require staff to support transformational research in disease control and vaccine development, including the study of coronaviruses. The proposed Learning Center will support job growth at these facilities with entry-level training for medical assistants, lab techs, and other health aides.

Martin County is also already home to many marine (American Custom Yachts, Armstrong Nautical Products, Bausch Enterprises, Blair Propeller & Marine Services, Bonadeo Boatworks, Chariot Robotics, Continental Shelf Associates, GyroGale Stabilizers, Jim Smith Boats, Ocean5 Naval Architects, Ocean Master Boats, Mack Sails, Seatorque Control Systems, Whiticar Marine Group, and Yacht Watchman) and aviation/aerospace (including Triumph Aerostructures, Paradigm Precision, PAC Seating Systems, STS Aviation Group, Advanced Technologies Group, EB Airfoils, ETS Power Group, EMC/RF Labs, Level 3 Inspection, and Kreiger Machine Company) businesses. These local employers have identified specific skills gaps in marine and aviation/aerospace manufacturing. The Learning Center will conduct hands-on training and offer accredited apprenticeship programs to meet local demand for a highly-skilled workforce.

Finally, the Learning Center will provide classes to improve the life skills of LMI individuals. This instruction will include English as a Second Language, preparing for the GED, financial literacy, homeownership, interview workshops, and parenting.

Martin County is partnering with Indian River State College to provide training at the Learning Center. A collaboration agreement is currently being developed and will be executed before construction of the facility.

The total project timeline is one year. Upon award, Martin County will conduct a two-month Request for Proposals process seeking bidders interested in developing the Learning Center. After procurement, the contractor will have a period of three months to complete design and engineering of the facility improvements. Next, a seven-month schedule will launch the renovation of Building 17, creation of vocational classrooms, and all necessary sitework and landscaping. Presuming an award date of October 1, 2021, Martin County will implement all project activities by September 30, 2022.

Martin County has conducted numerous successful construction and renovation projects across the region, including XXX, XXX, XXX, and XXX. These capital projects were conducted on-budget and on-time. Martin County procures qualified contractors to complete these construction and renovation projects, following all applicable federal and/or state funding requirements.

The project will be managed by George Stokus, Martin County's Assistant County Administrator. George has over 19 years of experience in municipal operations. He previously served as the Airport Manager at Witham Field, where he oversaw multiple improvement projects to runways, hangars, and other airport facilities. George has managed federal funding and is familiar with CDBG reporting requirements.

Martin County's partner Indian River State College is a public college based in Fort Pierce serving the counties of Indian River, Martin, Okeechobee, and St. Lucie. It has branch campuses in Okeechobee (Dixon Hendry campus), Port St. Lucie (Pruitt campus), Stuart (Chastain campus), and Vero Beach (Mueller campus), plus additional learning centers facilities in the area. Indian River State College is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools to award Associate and Baccalaureate Degrees. The institution also offers additional educational programs such as Technical Certificates, Applied Technology Diplomas, and Adult High School Programs. The college was named as one of the ten best community colleges in the United States by the Aspen Institute. Indian River State College has established programming in the health care, marine, and aviation/aerospace sectors.

and underemployed LMI residents. The proposed Learning Center will focus on preparing workers for entry-level positions in the health care, marine, and aviation/aerospace industries.

Federal resources are needed to design and renovate Building 17 at Witham Field into the Learning Center. Working in partnership with Indian River State College and area businesses, Martin County seeks to close skills gaps in the region and prepare workers for post-pandemic careers. Hands-on work opportunities and apprentice programs offered through the Learning Center will help to place LMI residents into high-wage jobs, reducing economic inequality.
